# **SUMMARY**

Diane Elson is Emeritus Professor in the Department of Sociology, University of Essex; and Visiting Professor at the WiSE Centre, Glasgow Caledonian University. In 2016, she was awarded the Leontief Prize for Advancing Frontiers of Economic Thought and in 2017 received an Honorary Doctorate from the Open University. In She was awarded the JSPE - Routledge International Book Prize in 2018 by Japan Society of Political Economy.

Her research interests are economic and social policy and the realisation of human rights, with a particular focus on economic development and gender inequality. She has been researching and writing about development issues for more than 30 years, and has published widely in journals and books. A chapter on her work is included in *Fifty Key Thinkers on Development* (edited by D. Simon, published by Routledge in 2006) and in *Key Thinkers on Development* (edited by D. Simon) Routledge 2019.

Prior to taking up a Chair in the Department of Sociology, Essex University in 2000, she held the Chair in Development Studies at the University of Manchester. She has also held posts in the universities of Oxford, Sussex and York; and has held visiting appointments at several universities in North America and Western Europe. She served as Vice President in the International Association for Feminist Economics (2004-6).

From 1998 to 2000, she held the post of Special Advisor to the Executive Director of UNIFEM, the United Nations Development Fund for Women. She continues to provide advice for its successor organization, UN WOMEN. She was a member of the UN Millennium Project Task Force on MDG Goal 3: Promote gender equality and women's empowerment (2002-5). She served on the UN Committee for Development Policy 2013-2021.

She is also active in civil society, in particular in the UK Women's Budget Group, a network of researchers and activists that analyses the impact of UK social and economic policy on women. She was Chair of the Commission on a Gender Equal Economy set up by the UK Women's Budget Group.
